Whereas, the landlords are the sole and absolute owners in possession of a building situated at K.P.Road Anantnag. 
NOW THIS RENT DEED WITTNESSETH AS UNDER

- 1. That the landlords have rented out the above mentioned building to the tenant for running their Nursing Home.
- 2. That the tenants will run their business in the above mentioned building.
- 3. That the landlords shall not evict the tenants from the said premises without prior notice of 180days after completion of term of tenancy of eight years

5. That in case any damage to the building same will be borne by the tenants.

The water/electric charges will be born by the tenants.

7. That the landlord shall be at liberty to inspect the premises as and when he chooses to do so and after vacation of building all damages will be born by the tenants.

8. That after expiry of each year, the tenants will pay the rent to the landlord

through the medium of proper receipt.

2. A Phat the rent shall be increased as per market rate after expiry of eight years

AP. That the tenants have paid one year rent in advance to the landlords is Rs,300000/=

11. That during eight years, the extra amount in addition to amount received by the landlord for eight years shall be liquidated by the landlord by way of rent of extra period.
