TERMS AND CONDITIONS :

1. That, the license holder shall run the business/trade under the provisions of Jammu & Kashmir Municipal Act 2000, Food Adulteration Act 1954 weights & Measures Act, Labour Act & Essential commodities Act & Rule made Hereunder;
2. That all the rules & regulations shall be adhered to which in force & which are made in force by the Government (Department of Urban Local Bodies (Municipal Council Anantnag) from time to time.
3. That the license shall comply promptly with notices issued by the Municipal Authorities in respect of Municipal Act;
4. That the License shall keep the premises neat, clean & sanitary condition to the best satisfaction of the Municipal Council.
5. That the license shall allow all the sanitation & other officers of the council or the Medical officer to inspect the premises;
6. That license holder shall pay the license fee well in time against proper G.R. Without which license is not valid & deemed to be void;
7. That any Food article, Drink or Drug if found unfit for human consumption or use shall be seized & destroyed at the risk, cost & the responsibility of License holder or shall be dealt under relevant laws as the case may be;
8. That the License shall not engage any person to work at his shop or licensed premises who is suffering or suspected from any infectious disease;
9. That this License shall remain in force up to the time limit as shown above;
10. That no meat without proper stamp of the Council is allowed to be sold or kept in the premises;
11. That the License shall not allow to sale any product banned by the Jammu and Kashmir Government/ Municipal Council Anantnag.
12. That the License will not use polythene within the shop/premises as it has been banned by the Government of J&K State and also by the Hon'ble High Court of Jammu & Kashmir State. In case, found FIR shall be lodged in the concerned Police Station as per the rule/order issued in this behalf.
13. That this licence shall not confer any right to property or tenancy infavour of the license holder.

Note:- That in case, the licensee shall fail to maintain the above terms & conditions then this license shall be deemed to be cancelled without any notice thereof & the license holder shall be dealt under law.
